CALLED TO ORDER: by Wright at 6:30 P.M., followed by the Pledge of Allegiance and Roll Call.

CLERK APPOINTMENT: Due to the resignation of LaBoda during November Board meeting, Clerk position was posted. Board received one applicant, Deputy Clerk Erskine. Duby made a motion to appoint Erskine as Clerk, supported by Conway; all in favor. **MC** Erskine to assume duties of Clerk, subject to election, November 2022. Erskine sworn in by Wright at the meeting outset.

APPROVAL OF AGENDA: Motion by Conway; supported by lutzi; all in favor. MC

TREASURER'S REPORT: Read by Duby. Motion to approve by Conway,2nd by lutzi; all in favor. **MC** Because bank service charges are greater than interest earned, Duby is looking for better rate on savings. More info to come. No word yet on COVID Relief monies. **CLERK'S REPORT:** November minutes read by Erskine. Correction in Blight Officer Report. The name recorded as Rosier shb Hoover. Motion to approve minutes with correction by lutzi; supported by Duby; all in favor. **MC** Invoices read by Erskine; motion to approve and pay bills including incoming bills by Duby. 2nd by Conway; all in favor. **MC**

GUEST: County Commissioner, Sandy Bristol noted the placement of information for Short Term Rentals in the Clare County Cleaver and concerns that it was not on the township website. Wright explained problems with website. lutzi has a lead on a new website provider. Bristol mentioned services available thru the VFW and Region 7 Commission on Aging, including dentures, hearing aids, glasses, regardless of income and the Vet's Coffee hour at Hayes Civic Center on 2nd Tuesday of Month.
